## Section G: Requirements for approved arrangement applications

**The proposed arrangement must cover each step of:**

- a. the operations to be carried out to prepare prescribed livestock for export
- b. the export operations to be carried out in relation to prescribed livestock that have been exported up until they are unloaded at a port or landing place outside Australian territory.

**The proposed arrangement must record that the applicant for approval of the arrangement is committed:**

- a. to meeting the objects referred to in section 3 of the Act that are applicable to the export operations and the prescribed livestock covered by the arrangement; and
- b. to complying with the requirements of the Act in relation to those operations; and
- c. to carrying out the export operations in accordance with the arrangement.

For variations to approved arrangements, the application must detail the proposed variation and include the varied approved arrangement.

For variations to approved export programs, the application must detail the proposed variation and must include the varied approved export program.

## Section J: Privacy notice

Your personal information may also be disclosed to relevant employees within your organisation for the purpose of approving your licence and to maintain the currency of your personal information for the purpose of the licence. Your personal information will be used and stored in accordance with the Australian Privacy Principles.

By completing and submitting this form you consent to the collection, use and disclosure of all personal information, including sensitive information, in this form to the relevant authorities in the importing country.

The department has not taken steps to ensure that the relevant authorities in the importing country do not breach the Australian Privacy Principles. This means that:
