Movement Transaction Record Form for Low Interest Species (Class 2 and Class 3) Exotic Birds

Information and instructions

Please read the information on this page carefully before you fill in your Movement Transaction Record (MTR) form.

Specimen details

A 'Specimen details' section must be completed for every individual specimen being sold. When more than two specimens are being sold in a single transaction, either fill in additional forms from this book or use an 'MTR Additional page' form available from the Department by calling **1800 720 466** or email exoticbirds@environment.gov.au

Individual ID

Class 2 and 3 specimens may be individually marked. See the guide '*Marking and individual identification of exotic birds for record keeping purposes*' at www.environment.gov.au/biodiversity/trade-use/exoticbirds

- Band** If the bird has a leg-band, record the unique code on the leg-band.
- Chip** If the bird has been microchipped, record the unique code of the microchip (provided by your vet).
- Tattoo** If the bird has been tattooed with an individual identification code record this code.
- DNA** If a DNA sample has been taken from the bird this sample should be numbered/coded. Record the number/code of the sample.
- Other** If you have individually marked the bird by an alternative method please record the method used.

Source

Under 'Source' the person selling, loaning, gifting or otherwise trading the specimen should tick the applicable box(es).

- *I acquired with an MTR* — Tick this box if you received an MTR when you purchased the specimen
- *Has a permit for import into Australia, or can be traced to lawfully imported specimens* — Tick this box if you have documentation to prove that the specimen you are selling was legally imported into Australia, or is the progeny of lawfully imported specimens
- *I can trace to a specimen held (or exempt) under the closed National Exotic Bird Registration Scheme (NEBRS)* — Tick this box if you have documentation linking the specimen being sold to a person who bred this specimen under the (now closed) NEBRS scheme
- *I acquired since the closure of NEBRS (11 January 2002) and available records have been compiled* — Tick this box if the specimen was acquired after the closure of NEBRS and you don't have any records to trace it to NEBRS registered stock. You should compile any available information about where the specimen came from such as receipts, cheque butts, original advertisement etc.
- *Is bred from parents on my premises and available records have been compiled* — Tick this box if the specimen being sold was bred from parents on your property. The buyer should ask the seller about the origin of the specimen's parents
- *Other* — Tick this box if none of the above options apply. Record any available information about where and when you acquired the specimen. If you have no records and no recollection of where the specimen was acquired write this down. Record keeping can commence from this point

Note: For each option listed above, it is important that the buyer sees or receives copies of source documents. The buyer should also ask appropriate questions to ensure they are satisfied with the validity of the documentation provided.
